INVITATION TO TENDER

Pursuant to Section 53 of Act No. 134/2016 Coll., On Public Procurement, as amended (hereinafter referred to as the "Act"), the Contracting Authority invites the Contractors to submit bids in the following below-the-threshold public contract:

Name of the public contract:	Gen 4 PCIe Protocol Analyser
Type of public contract:	supply
Type of procurement procedure:	simplified below-the-threshold proceedings pursuant to Section 53 of the Act
Subject of the public contract:	 The subject of the public contract is the delivery of the PCI Express protocol analyzer according to the PCIe specification revision 4.0 for the width x16 according to the technical parameters specified in the tender documentation. An appropriate probe to monitor the traffic between the host slot and the PCIe card under test must also be included. Delivery can be realized in the form of upgrading the existing Teledyne LeCroy Summit T3-16 analyzer owned by the client; or supplying a new device;
Access to tender documentation:	Part of the performance is to provide a minimum guarantee of 12 months for the supplied equipment. The tender documentation is freely accessible on the contracting authority's profile according to the information below.
Deadline for submission of tenders:	30. 9. 2019 until 11:00
Way to submit a tender:	Tenders shall be submitted in writing in electronic form through the contracting authority's profile - the E-ZAK system. Details are given in the tender documentation.
Qualification requirements:	The contracting authority requires proof of basic competence pursuant to Section 74 of the Act and professional competence pursuant to Section 77 (1) of the Act. Detailed requirements of the contracting authority to prove the qualification, including the required documents, are specified in section 6 of the tender documentation.
Rules for the evaluation of tenders:	The Contracting Authority will evaluate the tenders according to a single evaluation criterion - the lowest bid price in CZK without VAT.
